## TRADING BONUS TERMS AND CONDITIONS

### General Terms:

- 1.1. The Credit bonus is a bonus offered by UTrade Markets Ltd ("the company") to its clients under the following terms.
- 1.2. By opening a trading account under this Credit Bonus program, the Client acknowledges that he has read and agreed to be bound by these Terms and Conditions as well as to the Company's Trading Terms and Conditions.
- 1.3. The promotional period for this Credit Bonus offer shall run for specific period effective from 1st January 2024 until 31st December 2024.
- 1.4. The Company has the right to amend, alter or terminate this Bonus Promotion at its sole discretion, and at any time without any prior notice to either parties.
- 1.5. The Company reserves the right to refuse offering the Credit Bonus at its sole discretion without the need to provide justification. The Company will not be liable for any stop outs or any other consequences that result out of a Bonus cancellation and/or removal.
- 1.6. If the Company suspects that a Client has abused or attempted to abuse a promotion, or otherwise acted with a lack of good faith towards us, then the Company reserves the right, at its sole discretion, to deny, withhold or withdraw from that Client the Credit Bonus or promotion and if necessary to cancel any terms and conditions with respect to that Client, either temporarily or permanently, or terminate that Client's access to the service and/or block that Client's Account.
- 1.7. Any dispute or situation not covered by these Terms will be resolved by the Company Management in a fair manner.
- 1.8. The Credit Bonus only applies on new deposits and at the company's sole discretion also on selected re-deposits. An internal transfer between accounts is not counted as a deposit. Hence, the application for a bonus cannot be submitted for a deposit made by inter account transfers.
- 1.9. The Credit bonus only applies on Standard and Premium account types.
- 1.10. Participation in the Trading Bonus is not allowed for persons under the age of 18 or otherwise under the legal age in their country of residence ("minors").
- 1.11. Maximum amount which can be activated under this bonus promotion is limited to USD 40,000 or equivalent towards the base account currencies applicable per trading account.
- 1.12. Please note that you cannot switch between bonus programs offered by the company. ## Operating Terms

- 2.1. The Bonus Scheme will be automatically applied on the Client's initial minimum deposit of USD 1000 or more and subsequent deposits into the live trading account to which the Bonus Scheme has been applied.
- 2.2. For Example: If a Client deposits USD 1000 into an approved live account to which the Bonus Scheme has been applied, a credit bonus of USD 1000 will be credited to the account, effectively doubling the Client's equity.
- 2.3. **The Credit Bonus can only be used for credit purposes however, it is not losable and cannot be withdrawn under any circumstances.**
- 2.4. **If the equity of the account goes below the available bonus amount, then the bonus is removed automatically by the system. In other words, if the Cash Equity (Equity - Credit Bonus) becomes zero or less, all previously awarded Credit Bonuses will be cancelled and withdrawn from the respective Client's account. In these circumstances the Company shall not be liable for any consequences of the bonus cancellation, including, but not limited to, order(s) closure by Stop Out.**
- 2.5. **In case of selecting the credit Bonus, there will be no margin call alert.**
- 2.6. **Any withdrawal from the trading account will result in full bonus removal.**
- 2.7. Expert Advisors (EAs) are not allowed while the Bonus Scheme is applied.
- 2.8. These Terms and Conditions are made in English language. Any other language translation is provided as a convenience only. In the case of any inconsistency or discrepancy between original English texts and their translation into any other language, as the case may be, original versions of English shall prevail.
